e. Summary of Executed Contracts

Sondra provides an update on the main changes in the contracts and advises that we have not received the Notice of Award for some of the match funders yet. Dana states that there was a change in the grant agreement with the State, they removed the 6% match as a requirement, but we will still find ways to serve the families who receive that funding.

Sondra gives a brief update on the upcoming audits and monitorings for this fiscal year. She explains that although we have completed the AG audit, it remains open and therefore still appears in the report at this time.

Sondra discussed financials as of June 2023. We served 1148 children for School Readiness throughout both counties and 271 children for VPK in Walton county only. We stayed in compliance with all costs.

h. Match Funding

Members of the Board discuss the importance of match funding and how it helps the Asset Limited Income Constrained Employed or A.L.I.C.E. families who work but are just above the threshold to qualify to receive services. Match Funders such as United Way and the County Commissioners provide funds to assist these families.

i. Early HeadStart/HeadStart Program

Dana requests a letter of support for Children's Home Society of Florida on their application for this program.

Dana discusses Community Day and our partnership with United Fidelity Bank to recreate Storybook village. The event takes place November 4, 2023, at United Fidelity Bank in Fort Walton Beach.
